DEDUCTIBLE OPTIONS:	Basic Policy: Choice of 25%, 30%, 35%, 40%, 45%, and 50% Occurrence Loss Option (OLO): 5% Minimum Loss regardless of level of coverage				
UNIT DIVISION:	Basic Policy: By non-contiguous land within a tree type (Buy-up policies only)				
OCCURRENCE LOSS OPTION (OLO):	If damaged trees exceed 5% of the total amount of insurance, then the total damage is less than 5%, there is no claim.

Other Features

Comprehensive Tree Value Endorsement

This endorsement increases the value of trees that are either destroyed or fully damaged. The intent is to compensate growers for the loss of future revenue as a result of the damage. Fully damaged trees are defined as trees which have damage to wood that is three inches in diameter or greater.

Major Features

- · Payable on Stage II & III trees only
- Values vary by variety

Orange Trees:

- Early & Mid-Season Oranges
- Late Oranges
- Navel Oranges
- Temple Oranges

Grapefruit Trees:

- White Grapefruit
- Red Grapefruit

All Other Trees:

- Tangerines
- Tangelos
- Murcotts
- Half of any indemnity due is paid when the claim is finalized, with the remainder paid once evidence of replanting, subject to the following:
 - You must replant the same number of trees not necessarily citrus but must be a tree producing fruit grown for human consumption.
 - You are not required to replant the trees on the same ground.
 - · You are not required to replant the same variety of fruit trees.
- The Occurrence Loss Option (OLO) applies to any CTV claim if it was purchased on the basic policy.
